

1 **Minutes of the North Logan City**  
2 **City Council**  
3 **Held on December 17, 2014**  
4 **At the North Logan City Offices, North Logan, Utah**

6 The meeting was called to order by Mayor Lloyd Berentzen at 12:05 p.m.

7  
8 Council members present were: Kristen Anderson, Damon Cann, Nancy Potter, and John Bailey.  
9 (Roger Anderson was excused).

10  
11 Others present were: Nate Stephens, Alan Luce, and Lydia Embry.

13 **Adoption of Agenda**

14 Mayor Berentzen asked to include two items on the agenda, which are: a consideration for the  
15 council to approve hiring a part-time employee to assist City Treasurer, Peggy Giles; as well as to  
16 get approval to hire someone to work on economic development for North Logan City. He said  
17 the council has discussed this [last item] before, but said he would like the council to consider  
18 including adding money into the budget for this.  
19

20 *Nancy Potter made a motion to adopt the agenda as amended. Kristen Anderson seconded the*  
21 *motion. A vote was called and the motion passed unanimously with Nancy Potter, John Bailey,*  
22 *Damon Cann and Kristen Anderson voting in favor.*

24 **New Business**

25 **Consider approval of bid for asphalt work to be done in repairing the streets in the Johnson Park**  
26 **Subdivision.**

27 Mayor Berentzen and the council discussed previous issues that have occurred with Rupps  
28 Trucking, including them not fixing the driveway they damaged at a home in North Logan; and  
29 further discussed implementing ways to ensure there are no future issues if the city accepts  
30 Rupp's bid to do the work in the Johnson Park Subdivision.

32 *Nancy made a motion to select Rupps Trucking's bid for the Johnson Park Asphalt Project*  
33 *contingent upon there being enough money in the budget for part B of the project, and that a*  
34 *letter be send to Rupps Trucking detailing any past incidences regarding poor customer service;*  
35 *and that Rupps Trucking will not be eligible to bid on future projects in North Logan City if there*  
36 *any incidents on the Johnson Park Project. Kristen Anderson seconded the motion. A vote was*  
37 *called and the motion passed unanimously with Nancy Potter, John Bailey, Damon Cann and*  
38 *Kristen Anderson voting in favor.*

40 **Informational Items-Part Time Help and**

41 Mayor Berentzen let the council know that staff is intending to hire a part-time person to assist  
42 Peggy Giles with the workload in her department; and that staff will try to stay within the existing  
43 budget, and if that changes, it will be discussed with the council.

44 Mayor Berentzen also referred to previous discussions held with the council regarding economic  
45 development; and said Ernie Bleinberger had a \$20K proposal that Mayor Berentzen said he  
46 would like to include in the budget to work on this issue. He explained further, and said he will  
47 have more information for the council at a later date, but that he would like to have the money in  
48 the budget available for this work. He said this would likely come to the council as a line-item in  
49 the next budget revision for their approval. The council expressed their support of this.  
50

51 *Damon Cann made a motion to adjourn the meeting. Kristen Anderson seconded the motion. A*  
52 *vote was called and the motion passed unanimously with Nancy Potter, John Bailey, Damon*  
53 *Cann and Kristen Anderson voting in favor.*
