## MAJOR'S MESSAGE:

**M**In July the Council of Governments (COG) recommended to the Cache County Council to take out a bond of 20-25 million this year for road projects. In August the County Council considered this recommendation made by all the mayors and approved a bond of \$15 million. The bond will fund in January 2009 and be used to construct new roads that will have a direct impact upon reducing traffic congestion on Hwy 91 (Main). The COG re-convened and made a specific recommendation as to which road projects would be funded with the bond. It recommended that 100 East in Logan, *200 East in North Logan*, and 3200 South in Nibley receive funds in 2009 to complete these projects. The Cache County Council approved this recommendation.

Phase one of 200 East will begin at 1800 North and continue to 2200 North. In order to be ready to start construction of this road in 2009, the county approved \$250,000 for detailed engineering of the road.

This road will be two lanes in both directions, with a center median divider, bike lanes and pedestrian walks. The intersection at 1800 North will be expanded with a "Roundabout". A road right of way of 99' is required which is the same width as Hwy 91. It will be a "limited access" minor arterial road and will have free flowing traffic except at designated intersection points.

Last year we made a major improvement by widening 1800 North from 600 to 800 East. Also realignment was made near the intersection of 400 East along with a four way stop. This year the large willow trees along 1800 North near the intersection with 200 East will be removed to widen 1800 North from 100 to 400 East. We looked hard at whether the trees could possibly be saved; unfortunately they are well within the right-of-way and there isn't any way to work around them. The irrigation ditch on the north side of 1800 North will be piped and the road grade improved.

The preliminary cost estimates have been done and engineering of the road is underway. This work should be completed in about four months. Our goal is to start construction next summer. The benefit of having the first phase of 200 East completed will be seen immediately, and as it continues to develop to 2500 North and beyond it will truly be the most important road off Hwy 91 and be "Main off Main".

One might think that Hwy 91 can't possibly get more congested. It can, and will, but this first step will significantly help in reducing traffic congestion and the delays we all experience by sitting and waiting on this road just to travel a couple of miles.

## **Open Burning in North Logan City Limits**

North Logan City allows limited open burning within the city limits, mostly for Irrigation companies and agriculture purposes. Burn permits are permitted March 15<sup>th</sup> until May 30<sup>th</sup> and will open again October 1st (November 1<sup>st</sup> in dry years) for the rest of the year, when the Clearing Index is above 500 and Air Quality Control has declared a Green Burn Day. Irrigation companies may request an open burn permit to burn the weeds and other vegetation along the canal banks. Agriculture burning is designed for fence lines and ditches and to dispose of tree limbs and brush. Please note the following restrictions:

- No leaves, grass clippings or rubbish will be burned.
- No wood that has been chemically treated (construction wood) will be burned.
- No paper products will be burned
- All fires shall not be conducted within 50 feet of a structure or combustible materials.
- Buckets, shovels, garden hoses, or a fire extinguisher with a minimum 4-A rating shall be readily available.
- All fires will be out before dark.
- An adult will be with the fire at all times.

The North Logan City Fire Department shall issue permits, if the property meets all of the above requirements. To obtain a burn permit please call the "on call" Fire Duty Officer at **994-1530**.

## **Recreational Fires**

The term Recreational Fire Pit is the burning of materials other than rubbish with the total fuel area 3 feet or less in diameter and 2 feet or less in height used for pleasure, religious, ceremonial, cooking or

## **WHAT'S HAPPENING IN CITY COUNCIL?**

The City Council meetings for the month of October will be on the 1<sup>st</sup> and the 15<sup>th</sup>.

During the October 1<sup>st</sup> meeting the City Council will have a public hearing to open the FY2009 budget and receive public input on some proposed changes to the budget. The previous budget cycle closed at the end of June and as last year's books are closed out it is common to make some adjustments to the current year's budget. Last year almost all of the city's departments spent less than was budgeted and the surplus can be made available for needed projects this year - projects that didn't make the initial budget. During the development of this year's budget the council made the decision to not increase property taxes. They also reduced the energy sales and use tax rate from 5% to 4%. In doing so a considerable number of projects were left on the table as unfunded. Those projects need to be prioritized and considered for funding during this budget revision. Funds could also be transferred to capital "savings accounts" for future projects. During this meeting the council will be considering how to best meet the needs of the city with the funds available. Look for the official council agendas as they are posted at the city offices and the library. The Herald Journal is given a copy of the official agenda as well and they normally print it in the newspaper a day or two before the meeting.

### FROM THE CHIEF'S DESK

I have had several people call and ask questions about the newspaper article that came out several weeks ago relating to Off Road Vehicles that will be legal to drive on public roads. The legislation that was passed this last year that created State Code 41-6a-1509 Street-Legal all-terrain vehicle –Operation on highways goes into effect on October 1<sup>st</sup> 2008 applies only to certain cities and counties. One of the requirements is that the municipality be under 7,500 in population. North Logan has a population of just over 8,000. **The new law therefore does not apply so Off Highway Vehicles cannot be driven on public streets in North Logan.**

### **Election Corner**

The November election is within sight. If you don't think you will be around on Election Day, don't want to fight the lines, or for some other reason don't want to go to the polls, to vote, here is the voters' tip of the month:

**Vote at the office of the County Clerk if you cannot or choose not to go to the polls on Election Day**

Early voting can be done at the County Clerk's office. See below for specific times. Registered voters can vote without going to the polls as late as November 3<sup>rd</sup> if they do it by absentee ballot. That is the last day that the county clerk can accept an absentee voter application from a registered voter if that person votes in the office of the county clerk.
